Become a qualified FSC Lead Auditor

Our FSC auditor courses are based on FSC requirements as well as the ISO 19011 guidelines for auditors.

Our training is endorsed as fulfilling FSC's formal requirements for auditor training. ISO training is normally required for FSC auditors; however, you do not need to attend a separate, formal ISO course if you have passed our FSC lead auditor training¹.

If you pass the final exam, you will obtain a Certificate of Successful Completion. Those who do not pass the exam will receive a Certificate of Attendance.

Gain from intensive training

The training course consists of online modules and an in-person training session. It is an intensive, high-speed event designed to provide you with deep insight. Your learning takes place through a mixture of presentations and classroom exercises, with plenty of opportunity

for applying your new knowledge as soon as you have acquired it.

Some of the world's most experienced trainers will guide you through everything you need to learn to become a qualified FSC auditor.
